Instructions for New Membership Application

Requirements for Membership:

1. Members must be 18 years of age or older.
2. You must be a current member of the National Rifle Association. If you are not an NRA member when you apply for membership, you may join the NRA through the club (and save \$10!) by including \$25.00 for a one year NRA membership in your payment to the club.
3. You must pay the Club annual dues and a one-time initiation fee.
4. You must submit proof of having completed firearms safety training. Acceptable proof of training includes a Hunter Safety certificate, Concealed Weapon Permit, military discharge form, or proof of completion of an NRA certified safety training program.
5. You must be a Citizen of the United States of America.

About Membership Dues:

The membership year is from January 1 to December 31. The gate combination is changed each year on March 1st. Late renewals will be required to attend the range orientation and pay the \$25.00 initiation fee again. Non-members will be purged from the membership roster March 1 and no future newsletters will be sent to those addresses. Entry to club property on non-public event days will be considered trespassing except as a guest of a current member.

Membership Dues Schedule:

Membership dues will be **pro-rated** as indicated after April for the current year. Membership fees for the next year will be added to applications made during the final quarter of the year. When you prepay the dues you will be protected from any dues increase for the following year.

Spouse memberships:

Membership for spouses of club members is complimentary; however the spouse must meet all other membership requirements, and must submit proof of NRA membership and safety training.

Application procedure:

Fill out the membership application form and mail it along with your payment and the documentation of NRA membership and safety training to the club secretary at the address above or at the top of the application.

When your membership is accepted you will be notified by mail. You must attend a range and safety orientation at the club, after which you will receive your membership card with the gate combination. If you have any questions, please email them to csc.membership@gmail.com.

RANGE SAFETY RULES

- Membership cards must be worn at all times while on Club property. *Do not lend your card or give out the combination to anyone, they will be committing armed trespass.*
- Every person must identify themselves to the Range Officer upon entering the property. No Exceptions.
- Members are required to provide photo ID at the time they sign in with the Range Officer to shoot.
- Shooting hours are 9:00 a.m. until posted closing time. Closing times change seasonally and will be posted at the front gate and enforced by the Range Officer on duty.
- Only TWO guests per member per visit. *You are responsible for everything your guests do; you have to be with them while they are shooting.*
- Firearms may only be handled when the range is HOT. You cannot take guns or ammo to or from your car, unless the range is HOT.
- Changing from COLD to HOT or HOT to COLD range is the **SOLE** responsibility of the Range Officer on duty. Shooters are NOT to change the range condition without express permission of a Range Officer.
- Firearms shall be carried with the action OPEN and UNLOADED at all times, including to and from cars or from station to station.
- All shooting shall be done from the firing stations under the covered firing line, except shotgun and archery. Remember the firing line extends from property line to property line.
- Do NOT attach targets to the railroad ties or posts at the 25 yard firing line. Keep targets between the lines indicating the wooden supports so as not to destroy the supports.
- Do not attach targets or shoot at any structure supporting the roof area, the eyebrows or the fence.
- Shoot perpendicular to the firing line only.
- There shall be no shooting at any angle other than 90 degrees to the berm.
- **ALL BULLETS MUST IMPACT THE DIRT BERMS - Cannot hit the ground in front of berms.**
- Eye and Hearing Protection must be used by everyone on the firing line.
- No ALCOHOLIC beverages or containers.
- No NFA Title II firearms or accessories - No Automatic or auto-burst firearms.
- No Rapid Firing (3 seconds between shots).
- No Combat or Quick Draw Practice (No Holsters).
- Firearms shall not be carried in holsters or otherwise while the range is cold.
- Only law enforcement officers in uniform may carry holstered firearms on the range.
- No concealed carry at anytime on club property.
- Shotgun barrel length
 - No shotgun barrel lengths shorter than 18 inches on general target range.
 - No shotgun barrel lengths shorter than 22 inches on the trap range.
- No Shot size larger than 7 ½ for clay targets (7 ½, 8, or 9). (Trap)
- Excessively heavy/loud loads may also be restricted by the range officer. (Trap)
- Targets
 - No shooting metal targets closer than the 40 meter line.
 - No horizontal spinning metal targets.
 - No vertical spinning targets that employees a target above the center line of the pivot point.
 - No glass targets.
 - No propane tanks.
 - No exploding or incendiary targets.
 - All target placements must allow the shooter to see the berm 1 foot on every side of the target.
 - All targets shall be placed in a manner to insure bullets do not skip from the ground before berms.
- No Armor Piercing (AP) bullets, No Tracers.
- Shooter is responsible for replacing any property damaged by their actions.
- **Range Officers are in charge of the range at all times.**

NRA Gun Safety Rules

The Fundamental NRA Rules for Safe Gun Handling Are:

- Always treat all guns as loaded at all times.
- Always keep the gun pointed in a safe direction.
- Always keep your finger off the trigger until ready to shoot.
- Always keep the gun unloaded until ready to use.

When Using or Storing a Gun, Always Follow These NRA Rules:

- Know your target and what is beyond.
- Know how to use the gun safely.
- Be sure the gun is safe to operate.
- Use only the correct ammunition for your gun.
- Wear eye and ear protection as appropriate.
- Never use alcohol or drugs before or while shooting.
- Store guns so they are not accessible to unauthorized persons.
- Be aware that certain types of guns and many shooting activities require additional safety precautions.
- Regular cleaning and lubrication is important for your gun to operate correctly and safely.

Consult a Range Safety Officer if you have any questions about the rules.
